## Dean Lake Association Annual Meeting Minutes.

**Thursday, April 19, 2012** – New Community Church, 2340 Dean Lake Road NE About 70 Dean Lake Residents were present at the meeting.

**A mailing** was sent out 2 weeks prior to the meeting with an **agenda** for the meeting, an **invoice** for membership dues, a tentative weed & algae **treatment schedule** and a **magnet**. The magnet has an aerial view of Dean Lake that maps out the suggested wake zone path, The Park, The Island, The Narrows, Turtle Cove, Row Boat Cove, The Sand Bar and South Beach.

**Boat In and Out dates** of April 21, May 19, Oct 6 & 13 were announced. Dean Lake Membership Dues must be paid to get through the gate

Jan gave the **Treasurers Report**. The checking Account has a Balance of \$4846.99. There is \$18,126.03 in Money Market CDs. Dues were raised from 35.00 to 40.00 a year. There are 116 homes on the lake. More details are on the treasurer's report.

**Dues** cover projects such as pump maintenance, the park fence / guard rail, gate & lock maintenance, postage & printing for correspondence, and association liability insurance.

**Special Assessment Taxes** of \$85.00 per property goes to Plainfield Township and Grand Rapids Township. Four Mile Road is the border between the two townships. This money covers weed treatment etc. Plainfield Township has 7062.76 collected in taxes. The G. R. Township balance is \$4,588.00. Last year, \$13,400.00 was spent on weed control.

Pam talked about **4**<sup>th</sup> of **July** festivities.

The **Parade** will be on Wednesday July 4<sup>th</sup> @ 4:00 starting at the Island's south beach.

**Brunch** on Boats will be on Saturday, July 7 @ 10:00am.

This year's theme is "The Pirates of Dean Lake."

## Joel Dykema talked about **Happy Hour Parties**.

They will start this year on June 22 at Joel & Dan's with a 1920's theme.

Parties are usually on Fridays, do not require a theme and are BYOB.

A schedule will be emailed and available on the web page.

Bill showed everyone the **New Web Site** projected on a large screen.

He showed where it includes lots of information; events, lake conditions, pictures etc.

Various side discussions included, but were not limited to: The Great Heron rescue, the Largest Muskie in the state that was caught in 1976, the Ghost of Dean Lake in the 1950's.

There are huge turtles in Dean Lake. The turtles will sometimes eat the remains of a dead water balloon and can die from it. The group voted to not have a water balloon fight during the 4<sup>th</sup> of July boat parade. Water cannons are allowed, but not rocks.

Joel Steenstra from **Summit Labs** talked about the *State of the Lake*. Summit Labs is hired by the Dean Lake association to provide data. Professional Lake Management applies the chemicals to the lake If anyone sees potential problems, please feel free to contact Summit. The Environmental Protection Agency, Department Natural Resources and Department of Environmental Quality regulate what is registered to use in the lake. Our permit allows us to treat Eurasian milfoil and algae.

Eurasian Milfoil has been aggressively treated with trychlophere since 2006. Copper Sulfate is used to treat the lake for algae.

Turbidity (cloudy water) is caused by fine suspended matter in the lake. The boats, wind and the storm drains (at least 30) are the main causes of this. Very high lake levels and erosion last year also contributed to the problem. Chara carpets the bottom of the lake and helps to keep the sediment down. It's a multi-faceted problem, not solely a biological (algae) problem.

Last year Joel was more pro-active and had quicker treatment response times. Joel works with PLM and is getting more frequent, target specific, treatments.

A treatment schedule was distributed – any changes will be emailed and on the web site.

The long term weather forecast is calling for a dry summer, which will be great for the health of Dean Lake. Lack of ice on the lake this past winter kept the oxygen levels high which is also good for the lake.

**Fish** population – Four inch **Golden Shiners** were stocked last spring and about one hundred tagged, "Catch & Release" sterile 15" to 18" **Tiger Muskies** were released in the fall. If anybody catches one of the Tiger Muskies, it was requested that they register the tag number with Joel at Summit Labs.

**Dredging** the lake (through the narrows) is a work in progress.

**Elections** – The board will remain the same with the exception of Jo Ellenbaas replacing Nyleene Dodgson as Vice-President. Nyleene will become a trustee.

Meeting was adjourned at about 8:30 and a bunch of us went to Cheryl and Al's.
